Chair Manley asked if any correspondence had been received in regards to the item. Secretary Lopez said no correspondence had been received.

Chair Manley asked about the hours of operation. Associate Planner Lopez said they would operate seven days a week from 8:00 a.m. – 10:00 p.m. The Chair then asked about the strawberry stand structure currently on site and where it would be located during this event. Associate Planner Lopez said that it would be moved from its current location in order to conform with the approved site plan before the Commission. Anything not shown on the site plan would have to be removed.

The Chair opened the public hearing and asked if there was anyone in the audience to speak in favor of the proposed project.

Jay Eyler, owner of Santa's Garden, who operates the pumpkin patch thanked the Commission for allowing him to operate his business for the past 20 years in La Habra. Mr. Eyler clarified that the structure in question would be used as the office and it would be moved to the location as shown on the site plan.

Vice Chair Munoz asked if there were barriers to protect the guests from vehicles. Mr. Eyler said there is a chain link fence around the perimeter of the event.

Chair Manley asked about the parking spots shown on the upper part of the site plan. Mr. Eyler said those were employee parking spots.

The Chair then asked if there was anyone wishing to speak in opposition of the proposed project. There were none.

The Chair closed the public hearing and asked for discussion or a motion.
