Mayor Espinoza stated that this matter was not related to the current item being discussed and referred Lynn Franklin to speak with Police Chief Foster regarding this matter.

Mayor Espinoza closed the public hearing at 7:13 p.m.

Assistant to the City Manager Ferrier presented the staff report.

2. CONSIDER NEIGHBORHOOD TRAFFIC MANAGEMENT PLANS FOR NEIGHBORHOODS "C" AND "A"

Councilmember Shaw stated that he would abstain from discussion regarding Neighborhood "C" of the Neighborhood Traffic Management Plan (NTMP) because his mother in-law resides in that neighborhood.

Traffic Manager Plotnik presented the staff report. He noted that although the NTMP's that were approved by each neighborhood City Council could decide to make changes or reject the plans. He noted that if City Council approves the plans, staff still needs to meet with the neighbors to sign off giving their permission as to where the traffic calming measures would be placed.

City Manager Sadro clarified for the record: that the maps with the location of speed humps were a geographical location, and final placement being agreed upon by the homeowner that it was being placed near; that if the agreed upon location of a speed hump was too far away from the original placement then it could not be installed; confirmation that when the NTMP was discussed with the Neighborhood Traffic Committee, or with the residents voting, that it was communicated regarding the many factors for placement of speed humps; clarified that the NTMP for Neighborhood "E" was still being discussed and revised, the entire neighborhood agreed with the speed hump locations, but there was a contentious item regarding a "No Right Turn" sign, so staff would take all the comments made and send the NTMP back to the committee this week for approval on what they would like to do; confirmation that within the next few weeks to a month an updated plan would be presented to Neighborhood "E" to see if it would be supported or not, and then staff would bring that plan to City Council for approval and/or direction respectively; and expression of staff's preference for a contiguous plan.

City Council discussion included: confirmation of the number of residents in neighborhoods "C" and "A," how they voted, and the number that did not vote; verification of when votes regarding the NTMP's took place; the need for traffic calming around El Portal School in Neighborhood "E," a concern if a two-thirds consensus was not received, and the potential to either keep as one neighborhood or possibly splitting it into a northern and southern section.

Mayor Espinoza invited the public to testify regarding Neighborhood "C" and "A" at 7:41 p.m. There was no public testimony.

Jenny Valencia, La Habra resident, expressed concerns regarding the Neighborhood Traffic Management Plan for Neighborhood "E," in opposition to a "No Right-Turn" sign, and the need for traffic calming on El Portal Drive.

Shannon Berg, La Habra resident and a member of the Traffic Calming Committee, expressed concerns regarding traffic issues and the Neighborhood Traffic Management Plan for Neighborhood "E," in opposition to the placement of a "No Right-Turn" sign, and the need for sidewalks and traffic management at El Portal Drive, where El Portal Elementary School is located.

Mayor Espinoza closed public testimony at 7:53 p.m.

Councilmember Shaw asked about possible sidewalk installation on El Portal Drive as part of safety improvements. He noted that he spoke with the Superintendent of Lowell Joint Unified School District recently and was informed of the approved parking lot extension at El Portal Elementary School to Beach Boulevard that would help alleviate traffic flow.

Councilmember Gomez requested that the meeting be adjourned in memory of Melesio Ruiz and Johnnie Lozano. He reported that he attended the La Habra Chamber of Commerce Awards and Installation Luncheon.

Councilmember Shaw reported that he recently completed three Harvard Kennedy School of Management courses, and his receipt of an Executive Certificate in Public Leadership, that he attended the La Habra Chamber of Commerce Awards and Installation Luncheon and the City of Buena Park State of the City. He noted City Council's approval of Consent Calendar Item No. 7 for funding of the Euclid Street Traffic Signal Synchronization Program. He requested discussion and potential support of the development of a Veterans' cemetery in Orange County and a resolution in support be placed on the agenda of a future City Council meeting. Mayor Espinoza seconded.

Councilmember Simonian reported that he attended the La Habra Chamber of Commerce Awards and Installation Luncheon, and the three-day Independent Cities Association (ICA) Summer Seminar. He discussed Senate Bill 9 regarding zoning and lot splitting in California. He thanked Mayor Espinoza and Mayor Pro Tem Medrano for their attendance at the ICA Summer Seminar.

Mayor Espinoza reported that she attended the three-day Independent Cities Association (ICA) Summer Seminar. She discussed Senate Bill 9 regarding zoning and lot splitting in California, Senate Bill 10 which violated Article 2 Section A of the Constitution of California, and Senate Bill 1410 which eliminates minimum parking standards a half a mile from a bus stop, and the numerous community groups forming to stop Sacramento from controlling cities.
