Chair Munoz asked if any correspondence had been received in regards to the item. Secretary Lopez said no correspondence had been received.

Associate Planner, David Lopez, presented the staff report.

Chair Munoz asked if any of the Commissioners had any questions.

Commissioner Surich asked for clarification on how may building pads there would be for future restaurants. Associate Planner Lopez said there will be two suites that could be used for restaurants, however those have yet to be identified.

Chair Munoz asked if the existing entitlement for the alcohol license expires in December. Associate Planner confirmed that the Conditional Use Permit for a restaurant and the Conditional Use Permit for alcohol sales expires on December 31. He mentioned that the applicant does have the option to request a time extension that would keep those entitlements valid for one year. Chair Munoz asked if that time extension request would be presented to the Commission. Associate Planner Lopez said it would be a consent item and not a public hearing.

Commissioner Manley asked if the Denny's was still in operation at 1150 South Beach Boulevard. Associate Planner Lopez responded in the affirmative.

The Chair opened the public hearing and asked if there was anyone in the audience to speak in favor of the proposed project.

Amber Wesley, of DJM, representing the property owner, spoke in favor of the project. She mentioned that these two new suites will be designed to match the more updated modern architecture used for the new Starbucks building. She also said that they have had contact with interested parties both retail and restaurants who are interested in the center.

Commissioner Surich said she was happy to see that they were updating the look of the center.

Vice Chair Rojas asked for clarification on the façade of this new building, she wondered if it would match the façade of the Starbucks and Crumbl building. Ms. Wesley responded in the affirmative. She said that they hope to update the look of the center to match this new style.

The Chair then asked if there was anyone wishing to speak in opposition of the project. There were none.

The Chair closed the public hearing and asked for discussion or a motion.
