# 1. INTRODUCTION OF COMMUNITY OUTREACH LIAISON TEAM

Mayor Medrano invited Director of Community Services Fujio to the podium to introduce Community Outreach Liaisons David Aguirre and Paul Mahoney who presented a PowerPoint presentation.

Mayor Medrano, Mayor Pro Tem Gomez, and Councilmember Nigsarian thanked Community Outreach Liaisons David Aguirre and Paul Mahoney, Director of Community Services Kelly Fujio, and the La Habra Police Department for the hard work and community efforts.

Councilmember Espinoza requested the homeless outreach phone number be read aloud for the benefit of the viewing audience.

#### 2. PRESENTATION BY CR&R REPRESENTATIVES

Mayor Medrano invited Regional Vice Presidents Chrystal Denning and Julie Barreda to the podium. Chrystal Denning spoke regarding CR&R services, and offered support and apologizes for recent customer service trash hauler delays. She then presented a PowerPoint presentation on upcoming and general services provided by CR&R.

Mayor Pro Tem Gomez spoke regarding trash hauler service concerns and requested CR&R contact information for social media distribution.

Mayor Medrano spoke regarding CR&R staff shortages and customer service expectations; and suggested that CR&R be responsive and attentive to residential calls and concerns. He requested a public reminder of the proper disposal of batteries.

Councilmember Simonian spoke regarding waste cart locks as a deterrent to the unhoused rummaging through garbage bins on trash pick-up day, and asked if CR&R offers cart locks.
