Chair Munoz asked if there was anyone in the audience that wished to speak on any item not listed on the agenda. There were none.

CONSENT CALENDAR

The Chair explained the Consent Calendar procedures. He asked if there were any members of the public or any Commissioners that wished to have any item removed. There were none.

DULY NOTICED PUBLIC HEARING TO CONSIDER A REQUEST FOR DESIGN REVIEW 21-06, ZONE VARIANCE 21-03, CONDITIONAL USE PERMIT 22-03 AND CONDITIONAL USE PERMIT 22-04 FOR THE CONSTRUCTION OF AN AUTOMOBILE SERVICE STATION AND CONVENIENCE STORE WITH A REAR YARD SETBACK REDUCTION FROM 20 FEET TO SIX INCHES, AND A TYPE 20 OFF-SALE BEER AND WINE ABC LICENSE AT 750 NORTH HARBOR BOULEVARD.

Chair Munoz asked if any correspondence had been received in regards to the item. Secretary Lopez said none had been received.

Associate Planner Lopez presented the staff report.

Chair Munoz asked if any of the Commissioners had any questions.

Vice Chair Rojas wanted clarification in regards to which wall was allowed a zero-foot setback. Associate Planner Lopez explained that it was the wall on the eastern property line.

Chair Munoz asked if there was a condition of approval to enhance the south and east elevations on the new convenience store building. Associate Planner Lopez said that a condition was included in the draft resolution for the Design Review as project condition number four, which requires the applicant to submit elevation plans showing enhancements for those walls prior to permit issuance. Chair Munoz then asked about the existing retaining wall to the south and wondered if it was part of the former bank property. Associate Planner Lopez said that the five-foot high retaining wall will remain as part of this new project. Chair Munoz expressed concern about the grade difference between the property to the south. Associate Planner Lopez said automobile service station customers would not have access to that part of the property.

The Chair opened the public hearing and asked if there was anyone in the audience to speak in favor of the proposed project.

The applicant, David Berri, thanked the Commission for their time. He stated that they are looking to improve the aesthetics of this location by incorporating a new 7-Eleven convenience store. He mentioned that he was pleased with past projects which included adding a 7-Eleven to a Berri Bros. automobile service station at other locations outside of La Habra. Mr. Berri said he would be happy to answer any questions from the Commission.

Commissioner Manley asked Mr. Berri to identify the closest location outside of La Habra with a similar project proposal. Mr. Berri said he had recently completed a project with the same proposed elevations in the city of Anaheim, on the corner of Euclid Street and Broadway. He also mentioned that he is working on another similar project in the city of Stanton, on Garden Grove Boulevard, which involves converting their convenience stores to 7-Elevens. Commissioner Manley asked Mr. Berri about how many automobile service stations he owned. Mr. Berri responded that he owned and operated 20 automobile service stations.

Commissioner Surich said she was happy to see the new design proposed for the automobile service station and convenience store and thanked the applicant for their work on the project.

Chair Munoz asked if this new 7-Eleven would replace an existing location or if it was a new store in addition to the existing 7-Eleven already on Whittier Boulevard. Mr. Berri confirmed that the proposed project would be an additional, new store.
