1. DULY NOTICED PUBLIC HEARING TO CONSIDER A REQUEST FOR CONDITIONAL USE PERMIT 22-27 TO OPERATE A RETAIL STORE SELLING PRE-OWNED MERCHANDISE AT 551 WEST WHITTIER BOULEVARD.

Vice Chair Rojas asked if any correspondence had been received in regards to the item. Secretary Lopez said none had been received.

Assistant Planner O'Toole presented the staff report.

Vice Chair Rojas asked if any of the Commissioners had any questions.

Commissioner Manley asked what were the additional conditions of approval added to the project. Assistant Planner O'Toole described the three conditions that were added to the project including limiting the daily hours of operation to 9:00 a.m. – 8:00 p.m., limiting delivery hours to 9:00 a.m. – 6:00 p.m. on weekdays only and prohibiting the storage of unattended donations outside of the building.

Commissioner Surich asked if this was a second location. Assistant Planner O'Toole said the first location was previously on La Habra Boulevard but closed. The location at 551 West Whittier Boulevard will be the one and only location.

The Vice Chair opened the public hearing and asked if there was anyone in the audience to speak in favor of the proposed project.

Rose Marie Fisher, the applicant, addressed the Commission. Ms. Fisher explained that she has been a volunteer at the PTA Thrift Shop since 1992. She explained that they provide clothing to needy families as well as homeless people referred to them by Mr. Scott Miller, who was the head of the former CRCC (Community Resource Care Center). Ms. Fisher then proceeded to distribute copies of the PTA Thrift Shop's referral application form to each Commissioner and City Staff members present.

The Vice Chair then asked if there was anyone wishing to speak in opposition of the project. There were none.

The Vice Chair closed the public hearing and asked for discussion or a motion.

Moved by Commissioner Manley and seconded by Commissioner Bernier, approving Resolution No. 22-44, entitled: A RESOLUTION OF THE PLANNING COMMISSION OF THE CITY OF LA HABRA APPROVING CONDITIONAL USE PERMIT 22-27 TO OPERATE A RETAIL STORE SELLING PRE-OWNED MERCHANDISE AT 551 WEST WHITTIER BOULEVARD, MAKING THE APPROPRIATE FINDINGS, AS PER THE APPROVED PLANS AND SUBJECT TO CONDITIONS.
