**CALL TO ORDER:** Mayor Gomez called the Regular Meeting of the City Council of the City of La Habra to order at 6:30 p.m. in the City Council Chambers, located at 201 East La Habra Boulevard in La Habra, California.

Mayor Gomez welcomed the Boy Scouts from the Church of Jesus Christ of Latter Days Saints in attendance.

#### I. PROCLAMATIONS/PRESENTATIONS:

Mayor Gomez invited Beautification Committee Vice Chair Kim Praster to the podium to assist with the presentations.

- c. Presentation by California Domestic Water Company of their annual report.

Mayor Gomez invited California Domestic Water Company President Jim Byerrum to the podium.

#### II. PUBLIC COMMENTS:

Craig Alan Sheets, Brea, spoke regarding methamphetamine laboratories, schools, and hidden weapons.

Alison Koscak, 2000 Laguna Drive, spoke regarding air pollution/increased automobile emissions due to idling cars at the new drive through Starbucks being built at Beach Boulevard and Whittier Boulevard. Mayor Gomez referred Alison Koscak to Community and Economic Development Director Ho.

James Joyce, 1710 Laguna Drive, spoke regarding a development being constructed behind his home, the street widening project on Whittier Boulevard, and the petition he filed regarding traffic issues in his neighborhood. Mayor Gomez requested that James Joyce leave his phone number so City Manager Sadro can call him regarding the development and street widening concerns. Mayor Gomez referred James Joyce to Police Chief Price regarding traffic concerns.

Councilmember Blazey explained what the approval of the proposed Consent Calendar Item No. III.8 would be. He clarified the reasons Item III.8 might be removed from the Consent Calendar for separate discussion. He confirmed with residents from the neighborhood that the item is being requested to be removed for separate discussion.

Moved by Councilmember Beamish, seconded by Councilmember Blazey, and CARRIED UNANIMOUSLY (5-0) TO APPROVE CONSENT CALENDAR ITEMS III.1 THROUGH III.12; WITH THE EXCEPTION OF ITEM III.8 WHICH WAS REMOVED FOR SEPARATE DISCUSSION.

City Engineer Johansen presented the staff report.

Council discussion included: confirmation speed lumps are not being considered now because it is part of the Neighborhood Traffic Calming program (NTMP) process; clarified there are six neighborhoods scheduled ahead of this area for NTMP; verified this neighborhood is scheduled for NTMP in approximately three years; community meetings being part of the NTMP process and the effect on the priority list of neighborhoods scheduled ahead of this neighborhood; the proposed changes being an incremental approach; if a "Keep Clear" sign at Laguna Drive and Hacienda Road is needed; effects of delaying the proposed changes; positive law enforcement affects with the installation of the proposed changes; and the possibility of community meetings not having the desired outcome due to additional ideas from attendees; confirmation proposed changes can be installed in two weeks; and possible changes after the installation of proposed changes based on neighborhood input.

Mayor Gomez invited the public to testify at 7:05 p.m.

The following residents spoke in support of the proposed traffic amendments, but requested a small group meeting regarding left-hand and right-hand turns, and the following additional traffic

calming: an additional "Keep Clear" sign and traffic light at Lindauer Drive and Hacienda Road, and speed lumps:
