Jill Patterson, Branch Manager for the Orange County Library in La Habra, spoke regarding the number of parking spaced needed for the library and regulation of them.

Travis Cooper, California Municipal Finance Authority (CMFA), spoke introducing the CMFA Property Assessed Clean Energy (PACE) Program. He requested that the CMFA PACE Program be placed on a future agenda for consideration.

Jasmine, La Habra resident, spoke regarding Government Code 10.20.240 which states there is no parking at La Bonita Park from 10:00 p.m. to 6:00 a.m. She noted that there is limited parking at her apartment complex. III.4 Approve and authorize City Manager to execute Cooperative Funding agreement by and between the City of La Habra and the County of Orange contributing to the funding of construction of a year-round emergency shelter and multi-service center to serve the

homeless in North Orange County; and appropriate \$150,000 from the General Capital Projects Fund for the cost of the agreement.

Council discussion included: concern regarding City funds contributed from the General Capital Fund; potential legislation allowing funds from the Low-Mod Fund or from the Redevelopment Agency (RDA) or La Habra Housing Authority Funds to be spent outside the city boundaries; intent to refund the General Capital Projects Fund from the Low-Mod Fund, RDA, or the La Habra Housing Authority Fund; conversations with the ACCOC regarding legislation and being receptive regarding a refunding option being included; confirmation of Low-Mod Fund balance which is enough to cover the \$150,000 contribution cost; and confirmation homeless population of La Habra can utilize the emergency shelter if they meet the qualifications.

Moved by Mayor Pro Tem Shaw, seconded by Councilmember Beamish, and CARRIED UNANIMOUSLY (5-0) TO APPROVE AND AUTHORIZE CITY MANAGER TO EXECUTE COOPERATIVE FUNDING AGREEMENT BY AND BETWEEN THE CITY OF LA HABRA AND THE COUNTY OF ORANGE CONTRIBUTING TO THE FUNDING OF CONSTRUCTION OF A YEAR-ROUND EMERGENCY SHELTER AND MULT-SERVICE CENTER TO SERVE THE HOMELESS IN NORTH ORANGE COUNTY; AND APPROPRIATE \$150,000 FROM THE GENERAL CAPITAL PROJECTS FUND FOR THE COST OF THE AGREEMENT.

V. PUBLIC HEARINGS:

1. Duly noticed public hearing to consider a request for Mitigated Negative Declaration of Environmental Impacts 16-01 and Planned Unit Development 16-01 for a grocery store at 951-1001 East Imperial Highway.

Planning Assistant Schaefer presented the staff report.

Council discussion included: clarification this project submitted in March 2016; confirmation the City does not have a public art ordinance or policy, but public art is identified the City's adopted General Plan; identified projects that have conformed to a public art condition of approval; installation and maintenance costs of up-lighting; confirmation that the Kaiser Permanente project will have up-lighting, but other buildings in the area do not have up-lighting; confirmation the area is a retail corridor and similarly sized and type of projects are being required to have up-lighting and public art as a condition of their development; identified condition 5.17 "Up-Lighting" and condition 8 regarding "public art" was a concern for the developer; timing of project and awareness by ICI Development of these two conditions of approval; the coin operated shopping cart lock rental system; confirmation a developer has the option to pay the one percent of development cost towards public art, or construct public art as part of the project; and the need for a policy regarding public art.

Mayor Gomez opened the public hearing at 7:05 p.m.

Applicant Mick Meldrum, with ICI Development Company, spoke regarding not being aware of the two conditions of up-lighting and public art until late in the process. He expressed his concerns regarding the maintenance of the up-lighting. He counter-offered \$5,000 towards the public art condition of approval, compared to the one percent of project costs amount of \$32,000.

Matthew Baca, Director of Real Estate for Aldi Markets, spoke regarding the two conditions of up lighting and public art, and respectfully requested a compromise. He also spoke regarding the coin-operated shopping cart lock rental system.

Arlyn Buck, 281 South Monte Vista Street, spoke regarding the cart lock rental system. She expressed concern regarding lighting at the store and safety. Mayor Gomez clarified that the up-lighting issue was specific to landscaping. She received confirmation of the Aldi Market hours of 9:00 a.m. to 9:00 p.m.

There being no further testimony, Mayor Gomez closed the public hearing at 7:15 p.m.

Community Services Director Failla presented the staff report.

Council discussion included: identified plaza will be divided into three different sections with a specially designated area for the City Council's Paver Recognition Program; confirmation of the number of tiles in each section; and clarification there is no need to limit the number of tiles placed per year due to space restrictions.

Mayor Gomez invited the public to testify at 7:27 p.m. There was no testimony.

Moved by Councilmember Beamish, seconded by Councilmember Blazey, and CARRIED UNANIMOUSLY (5-0) TO APPROVE AND AUTHORIZE THE IMPLEMENTATION OF THE PROPOSED PAVER DONATION PROGRAM FOR THE NEW CITY HALL FACILITY.

- Operation Santa the City's annual collection of toys and food for families in need, is underway. The City gratefully accepts non-perishable food; new, unwrapped toys for children; and Wal-Mart and Target gift cards.

IX. COMMENTS FROM COUNCILMEMBERS:

Councilmember Beamish stated that he attended the Tamale Festival. He congratulated Community Services Director Failla and his staff for organizing the event. He stated that he attended the La Habra Police Department Banquet.

Councilmember Blazey stated he attended the Tamale Festival. He complimented staff, volunteers, and the La Habra Chamber of Commerce for organizing the event. He encouraged the community to remember the 75th anniversary of Pearl Harbor, December 7, 1941, and those who perished. He remembered his mother, Kathryn Blazey, and noted it would have been her 90th birthday on December 7.

Mayor Pro Tem Shaw stated he attended the Tamale Festival. He noted that the Orange County Transportation Authority (OCTA) funded the use of buses to transport people to and from the event. He stated that he presented a certificate and plaque, on behalf of City Council, to his former boss, Senator Huff, for his service to the City of La Habra for four years as a State Assemblyman and served eight years as a State of California Senator. He requested that an item regarding safe and sane fireworks, for July 4, 2017, be placed on a future agenda for consideration.

ADJOURNMENT: Mayor Gomez adjourned the City Council at 7:32 p.m. meeting in memory of Ethan Hawks, Kathryn Blazey, and for the lives lost at Pearl Harbor on December 7, 1941, to Monday, December 19, 2016, at 5:30 p.m. in the Administrative Conference Room 106, followed by the Regular Meeting at 6:30 p.m. in the City Council Chambers.
