Mayor Pro Tem Shaw stated that a report was not needed and requested the construction timeline regarding this item. City Manager Sadro explained that this item was to provide professional engineering services to complete design and provide final bid documents for the construction of the Lambert Road Rehabilitation Project from the City's western limit to its eastern City limit. He indicated that staff expected to have the engineer study for the Lambert Road Rehabilitation Project completed and back to Council within the next few months with a plan for construction. He stated that the funding for this project was included in the proposed Fiscal Year 2017-2018 Budget. He identified that the project would not include that portion of Lambert Road fronting the former Beckman site. He explained that City staff is working with City of Fullerton staff to discuss the possibility of the developer of this property being responsible to rehabilitate certain portions of both Lambert and Harbor Boulevards.

Council discussion included: the importance of the completion of the Lambert Road Rehabilitation Project; and the effects of truck traffic on the portion of Lambert Road fronting the former Beckman site.

V. PUBLIC HEARINGS:

1. Duly noticed joint public hearing to consider the adoption of the Fiscal Year 2017-2018 Municipal Budget.

Finance Director Shannon reported that the proposed budget balances available resources with expected expenses, addresses the Council's goals and objectives, provides resources for public safety and other services, and provides for the upkeep and improvement of the Citv's infrastructure. He itemized the various funds that make up the \$109.809,707 municipal budget. He reported that City Council reviewed the proposed FY 2017 – 2018 budget on Monday, June 5, 2017, and directed staff regarding funding for the Chamber of Commerce's "Shop La Habra" program. As directed, he stated that the proposed budget included the restoration of a proposed \$10,000 reduction in funding for the Chamber of Commerce's "Shop La Habra" program and allocated that amount to the Chamber's general support line item. He identified the three most significant challenges as: 1) City's reliance on property tax and the potential effects of a recession; 2) leveling off of sales/transaction tax growth due to online sales growth; and 3) the continuing increase in pension costs related to unfunded pension liabilities. He noted that staff would return to City Council with options to address the unfunded pension liabilities issue at mid-year. He identified the following as some of the more notable goals for Fiscal Year 2017-2018: 1) completion of the major residential, commercial, and development projects under construction such as Valentia, Kaiser Permanente medical office building, and the new Northgate Market; 2) begin construction of approved residential, commercial, and development projects such as the City Ventures project at the former City Hall location, the Olsen and Dr. Horton residential projects, and many restaurants such as a new In-N-Out Burgers, Farmer Boys, Raising Cane's, the Pizza Press, Tierra Mia Coffee, and On The Hook Seafood & Grill; and 3) begin and complete the Lambert Road Improvement Project.

Councilmember/Director Gomez thanked his colleagues for restoring the funding to the La Habra Chamber of Commerce.

Council/Director discussion included: proposed budget includes \$650,000 for alley rehabilitation; confirmed that alleys to be rehabilitated, as part of the Fiscal Year 2017-2018 proposed budget, do not include Community Development Block Grant (CDBG) funding; two to five alleys would be rehabilitated per year; updates regarding Vista Grande Park development, timeline, and potential funding; clarified that new rules apply to SB1 money versus other gas tax and that staff will be preparing for the new SB1 regulations; confirmed that Fiscal Year 2017-2018 does not include SB1 funding; and it is anticipated that approximately \$350,000 of SB1 funding is expected for the Fiscal Year 2018-2019.

Mayor/Director Espinoza opened the public hearing at 7:24 p.m. There was no public testimony and the public hearing was declared closed.

2. Duly noticed public hearing to consider and approve a resolution amending the City of La Habra Master Schedule of Fees pertaining to fees for general services, administrative services, community development services, building services, fire services, police services, ambulance services, public works services, utility services and penalties for municipal code and vehicle code parking violations.

Finance Director Shannon presented the staff report. He stated that Section 4.08.010 of the La Habra Municipal Code requires the City to adjust various fees and charges by the increase or decrease in the Consumer Price Index (CPI) for the Los Angeles-Orange-Riverside Metropolitan Statistical Area for the previous year. He reported that the CPI increase for 2016 was 1.89 percent; therefore, it is recommended that eligible user fees contained in the Master Schedule of Fees be increased by 1.89 percent, rounded to the nearest whole dollar.

Council discussion included: confirmed the fee amendments included only a CPI increase to those fees that are allowed a CPI adjustment; expressed concern regarding the fees that are less than the actual cost of providing the service; confirmed that any fee for a service that is set at a rate less than 100 percent of the cost for that service has been identified; fees that are less than recovery are effectively being subsidized by the General Fund; and directed staff to collect data to address the fees that are less than recovery and return with options for full recovery at mid-year.

Mayor Espinoza opened the public hearing at 7:32 p.m. There was no public testimony. The public hearing was declared closed.
