Mayor Shaw invited the Beautification Committee to the podium to assist with the presentations.

a. Beautification Award to the Wildey Family, 210 View Drive.

The Wildey Family was invited to the podium. Mr. and Mrs. Wildey accepted the award.

b. Beautification Award to the Failla Family, 900 La Serna Avenue.

The Failla Family was invited to the podium. Mr. Failla accepted the award.

II. PUBLIC COMMENTS:

Jose Alfaro, with Heavenly Culture, World Peace, Restoration of Light (HWPL) spoke regarding their work for peace in the world. He asked to speak with City staff to explain their organization and to answer any questions.

Arturo Estrada, resident of Park La Habra Mobile Home Park, described struggles he is experiencing at his residence and asked for City Council and City staff's assistance regarding his potential eviction and the potential evictions of some of his neighbors. He stated that he had already approached the management company Santiago Communities, Inc. regarding this matter.

1. Consider appointing a voting delegate and up to two alternate voting delegates to attend the League of California Cities (LOCC) Annual Conference, to occur at the Long Beach Convention Center from September 12th - 14th.

Assistant to the City Manager Ferrier presented the staff report.

Council discussion included confirmation that the voting delegate was Mayor Pro Tem Blazey and the Alternate Voting Delegate was Councilmember Espinoza for the 2017 Annual Conference.

Mayor Shaw invited the public to testify at 6:47 p.m. There was no testimony.

Councilmember Gomez nominated Mayor Pro Tem Blazey as voting delegate and Councilmember Espinoza and Councilmember Beamish as Alternate Voting Delegates to attend

the League of California Cities (LOCC) Annual Conference to occur at the Long Beach Convention Center from September 12-14, 2018. There were no other nominations.

Moved by Councilmember Gomez, seconded by Councilmember Beamish, and CARRIED UNANIMOUSLY (5-0) TO APPROVE TO DESIGNATE MAYOR PRO TEM BLAZEY AS VOTING DELEGATE, AND COUNCILMEMBER ESPINOZA AND COUNCILMEMBER BEAMISH AS ALTERNATE VOTING DELEGATES TO ATTEND THE LEAGUE OF CALIFORNIA CITIES (LOCC) ANNUAL CONFERENCE TO OCCUR AT THE LONG BEACH CONVENTION CENTER FROM SEPTEMBER 12-14, 2018.

2. Consider an application and resolution for the Mobile Source Air Pollution Reduction Review Committee Local Government Partnership Program.

Senior Civil Engineer Rangel gave the PowerPoint presentation. He introduced Ray Gorski, Technical Advisor for Mobile Source Air Pollution Reduction Review Committee Local Government Partnership Program (MSRC) who assisted in answering Council's questions.

Mayor Shaw invited the public to testify at 6:59 p.m. There was no testimony.

Council discussion included: confirmation the estimated total cost of the proposed project was \$107,000; clarification that some conduit and conductors were already installed for the project; review the purpose for funding of this type of projects by local government; inquired regarding the number of electric cars in La Habra and the other location of current electric charging stations in La Habra; identified that Mayor Shaw is a member on the MSRC Board from Orange County; confirmation that the majority of Orange County cities were participants in the MSRC program; inquiry if conduit and conductors already installed would qualify towards the City's matching funds amount; and clarification that once the application was approved staff would come back to Council regarding details of the project and for direction regarding identification of budget funds for the City's 25 percent matching amount for the project.

Ray Gorski thanked Council for considering this program. He noted that the 75 percent funding is already reserved by MSRC for the City of La Habra. He confirmed that the timeframe for submitting the application and approval of a resolution for the voluntary MSRC program was August 2, 2018. He clarified that the City would have five years to plan and spend the MSRC funds. He suggested that the City use the Department of Motor Vehicle (DMV) registration fees that the City receives quarterly (AB2766 funds) to help fund the City's required 25 percent funds match towards this project.

Mayor Shaw thanked Ray Gorski for attending the meeting.

Moved by Mayor Shaw, seconded by Mayor Pro Tem Blazey, and CARRIED UNANIMOUSLY (5-0) TO APPROVE to:

- a. RECEIVE THE MOBILE SOURCE AIR POLLUTION REDUCTION REVIEW COMMITTEE PRESENTATION; AND
- b. AND ADOPT **RESOLUTION NO. 5859** ENTITLED: A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LA HABRA, STATE OF CALIFORNIA, ADOPTING THE MSRC LOCAL GOVERNMENT PARTNERSHIP PROGRAM FOR \$80,700 MSRC MATCHING FUND.

Councilmember Beamish reported that he attended the City's 4th of July event. He commended City staff, La Habra Police Department, and Scott Ward for their work on the event. Councilmember Beamish announced that the La Habra Journal newspaper would be published in print form again, prior to the La Habra Corn Festival, by former owners Jane and Steve Williams with subscriptions available.

Mayor Pro Tem Blazey reported that he attended the City's 4th of July event. He urged the community to continue their support of the City's 4th of July event at its new location. He

thanked Community Services Director Failla, Community Services Manager Albarian, and City staff for their work on the event.

Councilmember Espinoza reported that she attended the City's 4th of July and Concerts in the Park events. She thanked Community Services Director Failla for his commitment to the 4th of July event. She noted that she had attended the last few Mysterium Theatre productions at the La Habra Depot Theatre. She encouraged the community to attend future productions. She thanked City staff and everyone who organizes City events.

Councilmember Gomez reported that he represented the City Council at the Independent Cities Association (ICA) conference in Carlsbad, California where the following subjects were covered: drone ordinances, pension reform, urban planning, the future of energy, emergency operations, and the opportunities and risks of cannabis. He asked that the meeting be adjourned in memory of longtime La Habra resident Ernie Zoeter, who was almost 100 years old, married to Kitty Zoeter, and was active in the building of the La Habra Historical Museum.

Mayor Shaw stated that City Manager Sadro is on vacation. He welcomed Community and Economic Development Director Ho as the Acting City Manager. He also welcomed Patrick Errett from the Los Angeles County Fire Department who was recently transferred to La Habra. Mayor Shaw reported that he attended the 4th of July event. He announced that his aunt was proposed to for marriage by her boyfriend on the stage at the event. He thanked everyone who helped with organizing the proposal.
