Peter Cruz, La Habra, submitted a public comment via email asking about Executive Order N-37-20 issued by Governor Newsom prohibiting the enforcement of eviction orders for renters affected by COVID-19. He asked City Council to take action placing a temporary ban on City of La Habra evictions and to seek federal funding for rental assistance.

Amy Abshier, University of California, Irvine, School of Law, submitted a public comment via email in support of a temporary moratorium on evictions for City of La Habra renters affected by COVID-19.

Lyndsey Lefebvre, La Habra, submitted a public comment via email encouraging City Council support of Executive Order N-37-20 issued by Governor Newsom prohibiting the enforcement of eviction orders for renters affected by COVID-19.

Greg Jones, Jones RE Broker, submitted a public comment via email in support of Consent Calendar Item III.A.7.
