Sandi Baltes, Marketing and Outreach Director of Friends and Family Health Clinic located at 501 S. Idaho Street, stated the clinic has been designated a federally qualified healthcare clinic and is no longer aligned with the Institute for Healthcare Advancement (IHA). She introduced two members of the staff who are being trained and certified in counseling on California Care that is part of the Affordable Care Act (ACA). Mayor Beamish stated he and Councilmember Espinoza have served on this committee for some time. He discussed the continuity of appointing the current Mayor and Mayor Pro Tem yearly. Councilmember Gomez expressed concern regarding the work schedules of certain councilmembers and their unavailability to meet during the day. Mayor Beamish inquired if the auditors can meet in the evenings. Assistant City Manager/Director of Finance and Administrative Services Sadro confirmed the auditors could accommodate different schedules. Mayor Beamish suggested that the matter of appointing the Mayor and Mayor Pro Tem yearly as a permanent appointment be brought to counsel at a later date for discussion. Councilmember Gomez supported the appointment of Mayor and Mayor Pro Tem to serve on the Internal Audit Committee.

He stated that he attended the La Habra Police Association Awards and Holiday Banquet and announced the award recipients as follows: Supervisor of the Year - Sergeant Jeff Baylos, Officer of the Year – Corporal Scott Irwin; Reserve Officer of the Year – Joshua Goldmark; Civilian Personnel of the Year - Records Specialist Viviana Alfaro: Support Personnel of the Year - Radio Patrol Volunteers: Patrick Borja, Esther Dickenson, Steve Hopple, Fred Milam, Georgeanna Milam, Allen Nisle, Ted Singer, Jose Valdivia, and John Madsen; and Support Personnel of the Year - Part-Time Dispatcher David Gonzalez. He congratulated the award recipients. He congratulated the new POA President Sergeant Jim Tigner. He thanked Council for their support in appointing him as Mayor. He thanked his wife Nancy Beamish for her support. He noted that during the last 5 years, city government, private businesses, school districts, and non-profits across the country, and in our the La Habra community, have needed to adapt to the challenging and changing economic conditions. He stated that he believes it has made the La Habra community stronger and led to more cooperative and collaborative relationships. He commented that more now than ever, as the economy continues to improve, he believes that cooperation and collaboration is the fundamental ingredient to the future success of the City and community. He stated that La Habra relies upon a healthy, vibrant, local economy to fund public services and programs. He added that without a solid tax base, which is a product of a strong economy, La Habra would lack the means to deliver the services the City provides. He stated a strong and vibrant local economy benefits the entire community and helps all to succeed. He commented that as stewards of the public's trust. City Council has a responsibility to look towards the future, to think how the Council can build a stronger community. He stated that, without a doubt, a strong and robust business economy is a key to that future. He commented that during his term as Mayor he will encourage the City to enhance and strengthen its working relationship with all the community groups within the City; especially with the business community and the La Habra Chamber of Commerce, and boost our existing efforts to support its success. He stated the City has done a good job of maintaining support for our businesses in the past, but we can do better. He quoted Will Rogers' saying, "Even if you are on the right track you will get run over if you just sit there." He stated with the General Plan

nearing completion, this is the right time to build a resilient foundation that will carry our community toward an even greater success. He expressed that he is focusing on the City's initiatives, policies, regulations, and relationships with the business community. He stated that the following questions need to be answered:

- How can we improve the policies and procedures that affect business?
- How can we become a better partner and create and environment most conducive to economic success?
- What are other cities doing in that regard and how successful have they been?
- What have been their best practices?
- What have been the impacts associated with a given practice?
- How can we include the La Habra Chamber of Commerce and other business representative groups in this process?
- How do we better share information among the groups?
- Is there something more the City can do to help attract businesses we would like to see in La Habra?

Mayor Beamish commented that additionally he believes it would benefit the community to create an Ad Hoc Economic Development Committee composed of representatives from the La Habra Chamber of Commerce, other business groups, and key City staff to provide advice to the City Council on economic development matters. He requested staff to gather information on these issues and report back to Council with a recommendation regarding the next steps at the Council Meeting to occur on December 16, 2013. He challenged his colleagues to review the General Plan Update, chose a section/area, and work on ideas to change La Habra over the next few years. He concluded by saying that he believes by working together we will build a stronger La Habra.

Mayor Beamish announced that the City Council will be participating in a land use field trip on December 3, 2013 with the Planning Commission, and it has been noticed as a special meeting to be held in the Administrative Conference Room 106 at 8:00 a.m. and leaving for the field trip soon thereafter.

XI. ADJOURNMENT: Mayor Beamish adjourned the meeting at 7:15 p.m.
