- V. **PUBLIC HEARINGS:** None at this time.
- VI. CONSIDERATION ITEMS:
- 1. Consider the issuance of La Habra Utility Authority water revenue bonds, in an amount not to exceed \$24.5 million, to refund the 2003A La Habra Civic Improvement Authority (CIA) water revenue bonds, refinance the 2011 Utility Authority water credit line, and to provide capital construction funds for water system capital improvements; and authorize the Executive Director to execute all bond documents necessary to finalize the sale of the bonds.

Assistant City Manager/Director of Finance and Administrative Services Sadro presented the staff report. He described the history of measures taken to address infrastructure issues, meeting water demands, and the increasing cost of purchasing and delivering imported water to meet the responsibility of providing drinking water at a reasonable cost. He stated that the issuance of the proposed \$21.5 million water revenue bond would refinance the \$12 million line of credit, refinance the 2003 water bonds to the existing term, and set aside \$3 million for future water system improvements. He stated that the current water rate structure has been designed to accommodate this additional expense.

In response to Councilmember/Director Gomez's inquiry, Assistant City Manager/Director of Finance and Administrative Services Sadro stated that it was a good environment to issue debt since interest rates are at very low levels compared to historical rates.

In response to Councilmember/Director Beamish's inquiry, Assistant City Manager/Director of Finance and Administrative Services Sadro clarified that should the interest rates rise to a level where the refunding no longer makes financial sense, the refunding of the 2003 Bonds would be removed from the proposed bond transaction.
