a. Recognition by American Cancer Society of the volunteers for Relay for Life in La Habra.

Mayor Espinoza invited Taryn McDonald and Nina Cruz Walker, "Relay for Life" Event Chair, with the American Cancer Society who presented a plaque to the City of La Habra and presented certificates to the following volunteers: Recreation Specialist Bernard Nolen; Community Services Recreation Division's: Brett Christensen, Taylor Sais, Kyler Asato, and Brian Ault; Recreation Manager David De Leon; Program Coordinator Katie Elmore; and Community Services Director Sal Failla. Taryn McDonald thanked Mayor Espinoza and the City Council for their support and involvement in the event. She announced that next year's American Cancer Society "Relay for Life" fundraiser will be held on June 7 and 8, 2014 at Imperial Middle School. Mayor Espinoza thanked the Community Services staff.

b. Presentation by OC LAFCO of the CALAFCO Government Leadership Award to La Habra.

Mayor Espinoza invited Orange County Local Area Formation Commission (LAFCO) CEO Carolyn Emery to the podium. She explained the Community Islands Task Force and shared the California LAFCO Government Leadership award with, and thanked, the City of La Habra. Mayor Espinoza expressed her appreciation.

V. PUBLIC HEARINGS:

1. Duly noticed public hearing to consider ordinance approving Zone Change 13-03 repealing and replacing Sections 18.08.110 and 18.08.040 of Chapter 18.08 (General Regulations) of Article I (General), and adding Chapter 18.54 (Medical Marijuana Dispensaries) of Article III (Special Zones) of Title 18 (Zoning) of the La Habra Municipal Code, relating to medical marijuana dispensaries.

Community Development Director Haack explained the history of the City of La Habra medical marijuana moratorium and reviewed the decision made in May 2013 by the California Supreme Court on the City of Riverside vs. Inland Empire Health and Wellness, Center, Inc. case. He clarified that marijuana continues to be a federally banned substance and the California Supreme Court has ruled that the decision to permit medical marijuana dispensaries, and subsequent distribution, is specifically within the zoning powers of local jurisdictions. He stated the staff's recommendation to prohibit medical marijuana dispensaries and distribution from such locations is within the California Supreme Court's decision. He noted that the proposed ordinance would allow for small groups of no more than five individuals to cultivate, possess, and consume marijuana for medical purposes. He stated staff believes this would not constitute feasible commercial operation within the city, so therefore a storefront could not be established.

Police Chief Price and Police Captain Johnstone presented the various criminal issues relating to medical marijuana dispensaries. Captain Johnstone reported that the two dispensaries that had opened in La Habra were very problematic and were not compliant with either federal or state law. He stated, to the best of his knowledge, there were no dispensaries in any Orange

County cities and no ordinances allowing dispensaries at any of the cities directly adjoining La Habra.

Mayor Espinoza opened the public hearing at 6:58 p.m.

The following individuals spoke in favor of medical marijuana dispensaries in La Habra and expressed their opposition to the proposed ordinance:

Mayor Espinoza asked for a show of hands vote of the audience of those who oppose the proposed ordinance and then those who supported the ordinance. No count was taken.

Mayor Espinoza closed the public hearing at 7:41 p.m.

Council discussion included: clarification of the purpose for allowing for small groups of no more than five individuals to cultivate, possess, and consume marijuana for medical purposes; clarification that the statement that the proposed ordinance is unconstitutional and a violation of the First Amendment is invalid.

Council expressed their support of staff's recommendations to oppose medical marijuana dispensaries in La Habra; however they expressed their support of those who require the use of medical marijuana.

Mayor Pro Tem Beamish reported that he met with Erik Chan, toured the La Habra Cares facility, and researched information on medical marijuana. He stated the City of La Habra voted against Proposition 215, the Compassionate Use Act (CUA) in 1996 and that the State of California and the County of Orange voted in support of the CUA. He expressed his support of local control in this area and reiterated that the California State Supreme Court gave cities the right to zone appropriately. He explained further the results of his research. He expressed support of collectives of five people and the proposed ordinance.

Moved by Councilmember Gomez, seconded by Mayor Espinoza, and CARRIED 4-0 TO APPROVE FIRST READING OF **ORDINANCE NO. 1746** ENTITLED: AN ORDINANCE OF THE CITY OF LA HABRA, CALIFORNIA REPEALING AND REPLACING SECTIONS 18.08.110 AND 18.08.040 OF CHAPTER 18.08 (GENERAL REGULATIONS) OF ARTICLE I (GENERAL), AND ADDING CHAPTER 18.54 (MEDICAL MARIJUANA DISPENSARIES) OF ARTICLE III (SPECIAL ZONES), OF TITLE 18 (ZONING) OF THE LA HABRA MUNICIPAL CODE, RELATING TO MEDICAL MARIJUANA DISPENSARIES.

2. Consider reading title of and setting a public hearing date to consider adoption of an ordinance amending Title 15 "Buildings and Construction" of the La Habra Municipal Code, Chapter 15.04 - 15.18, 15.24, 15.32, 15.40, Sections 15.40.030, 15.44.010 - C, 15.60.010 - A, 15.68.020 - 15.68.030, adopting the 2013 Editions of the California Building, Residential, Green Building, Electrical, Plumbing, Mechanical, and Energy Codes and the 2012 International Swimming Pool and Spa Code, the 2012 International Property Maintenance Code, and the Related Model Codes with appendices and amendments.

Community Development Director Haack stated that staff was requesting Council to set a public hearing date of November 4, 2013, to consider adoption of the ordinance.

Council discussion included: confirmation that cities are held liable if they choose not to follow state regulations, and directed staff to review codes from a local perspective to remove those that are not beneficial to create less regulation for La Habra residents.

Mayor Espinoza invited the public to testify at 8:00 p.m. There was no public testimony.

Moved by Councilmember Gomez, seconded by Mayor Pro Tem Beamish, and CARRIED 4-0 TO APPROVE THAT THE COUNCIL READ THE TITLE OF THE ORDINANCE: AN

ORDINANCE OF THE CITY COUNCIL OF THE CITY OF LA HABRA AMENDING TITLE 15 "BUILDINGS AND CONSTRUCTION" OF THE LA HABRA MUNICIPAL CODE, CHAPTER 15.04 - 15.18, 15.24, 15.32, 15.40, SECTIONS 15.40.030, 15.44.010 - C, 15.60.010 - A, 15.68.020 - 15.68.030, ADOPTING THE 2013 EDITIONS OF THE CALIFORNIA BUILDING, RESIDENTIAL, GREEN BUILDING, ELECTICAL, PLUMBING, MECHANICAL, AND ENERGY CODES AND THE 2012 INTERNATIONAL SWIMMING POOL AND SPA CODE, THE 2012 INTERNATIONAL PROPERTY MAINTENANCE CODE, AND THE RELATED MODEL CODES WITH APPENDICES AND AMENDMENTS; AND SET THE PUBLIC HEARING DATE OF NOVEMBER 4, 2013, AT 6:30 P.M. IN THE COUNCIL CHAMBERS LOCATED AT 201 E. LA HABRA BOULEVARD, LA HABRA, CALIFORNIA TO CONSIDER ADOPTION OF THE ORDINANCE.

3. Consider the Imperial Highway at Briercliff Drive Traffic Control Improvements Four Month Evaluation Report.

City Engineer Johansen presented a Powerpoint staff report. He stated in January 2013, Council approved the partial closure of the intersection to explore adjustment of the Cajon Drive and Imperial Highway traffic signal and to increase traffic enforcement in the area. He reported that installation of the temporary traffic access restriction at Imperial Highway and Briercliff Drive was completed in March 2013; and the traffic signal modifications at Imperial Highway and Brass Lantern Drive/Cajon Drive were completed in June 2013. He reviewed the before-after effect of the closure of Briercliff Drive to exiting traffic at Imperial Highway and the effect the closure had on the intersection of Imperial Highway and Brass Lantern Drive/Cajon Drive. He stated the La Habra Police Department continues to monitor this neighborhood and approximately 10 citations have been issued over the past several months related to speeding, stop sign infractions, pedestrian infractions, and other violations.

Council discussion included: confirmation there have been no complaints and only one concern received regarding speeding has been received from the residents regarding the improvements.

Mayor Espinoza invited the public to testify.

Mark and Arsega, 2500 Greenbrier Lane, spoke in support of a full closure of the intersection at Greenbrier Lane and Imperial Highway. They expressed their concerns regarding safety due to the location of their driveway with respect to the intersection. He noted that they have observed at least five vehicles per day are making illegal turns.

Council discussion included: confirmation that further improvements have not been budgeted in the current fiscal year budget, the potential for additional funding at mid-year budget review for further traffic measures; review concerns regarding pedestrians on the north side of Imperial Highway year round; review possible placement of posts in place of the Raised Pavement Markers; potential benefits to construct permanent raised medians at Imperial Highway and Briercliff Drive to restrict the traffic access at this location; and the potential effects of a permanent closure of the intersection of Imperial Highway and Briercliff Drive.

Moved by Councilmember Gomez, seconded by Councilmember Shaw, and CARRIED 4-0 TO APPROVE RECEIVE AND FILE THE IMPERIAL HIGHWAY AT BRIERCLIFF DRIVE TRAFFIC CONTROL IMPROVEMENTS FOUR MONTH EVALUATION REPORT; BRING THE ITEM BACK TO COUNCIL AS PART OF THE MID-YEAR BUDGET REVIEW; AND INSTRUCT THE LA HABRA POLICE DEPARTMENT TO INCREASE PATROLS IN THE AREA.

Mayor Espinoza stated that she attended the La Habra Chamber of Commerce 1st Annual La Habra Oktoberfest and International Food Fair. She commented the event was very successful, but a larger venue is needed for next year.
