## II. CLOSED SESSION:

III. 3. Approve and adopt a resolution authorizing benefit changes for Head Start employees effective January 1, 2014.

Assistant City Manager/Director of Finance and Administrative Services Sadro presented the staff report. He reported that 28 part-time employees are considered full-time employees under the new Affordable Care Act (ACA). He reported that in compliance with the ACA, the City must offer these employees affordable medical insurance coverage and therefore must increase the monthly insurance contribution from \$200 per month to \$400 per month. He reported the new contribution amounts will take effect on January 1, 2014, and will be fully covered by the Head Start grant funds.

Council discussion included: clarification that the Head Start employees are fully funded by the federal government Head Start grant; Head Start County Officials have been contacted to confirm that there are sufficient funds this year to fund this benefit change; clarification that all 28 Head Start employees may not choose to receive this benefit and those who choose not to receive this benefit will not receive the difference in pay; other potential impacts the City may be facing under the ACA; and clarification that the City has approximately 275 part-time City employees whose hours are being closely monitored and should not be impacted by the ACA since it is anticipated that their average hours over 12 months should fall below 30 hours per week.

Mayor Espinoza invited the public to testify. There was no public testimony.

Moved by Councilmember Gomez, seconded by Councilmember Blazey, and CARRIED UNANIMOUSLY 5-0 TO APPROVE AND ADOPT A RESOLUTION AUTHORIZING BENEFIT CHANGES FOR HEAD START EMPLOYEES EFFECTIVE JANUARY 1, 2014; AND APPROVE AND ADOPT **RESOLUTION NO. 5601** ENTITLED: A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LA HABRA AMENDING RESOLUTION NO. 5552 PERTAINING TO THE CITY COMPENSATION PLAN.

## V. PUBLIC HEARINGS:

1. Duly noticed public hearing to consider an ordinance amending Title 15 "Buildings and Construction" of the La Habra Municipal Code, Chapter 15.04 - 15.18, 15.24, 15.32, 15.40, Sections 15.40.030, 15.44.010 - C, 15.60.010 - A, 15.68.020 - 15.68.030, adopting the 2013 Editions of the California Building, Residential, Green Building, Electrical, Plumbing, Mechanical, and Energy Codes and the 2012 International Swimming Pool and Spa Code, the 2012 International Property Maintenance Code, and the Related Model Codes with appendices and amendments.

Councilmember Gomez acknowledged that this would most likely be Chief Building Official Roy Fewell's last presentation before his retirement scheduled by the end of the year. He commended him for his service to the City.

Chief Building Official Fewell thanked Councilmember Gomez for his kind words and presented the staff report. He reported that local governments are required to adopt and regulate to the most recent editions of the California State Building regulations. He stated that local governments may amend the code to make it more restrictive, with specific findings, but not less restrictive. He noted that the City of La Habra always attempts to make the fewest possible local amendments. He described the two proposed modifications as mandating Minimum Class B roof coverings and a prohibition of No. six (6) or smaller aluminum wiring and aluminum conductors, unless provided with continuous inspection.

Mayor Espinoza opened the public hearing at 7:06 p.m. There was no public testimony and the public hearing was closed.

There was no Council discussion or questions.
