VI. CONSIDERATION ITEMS:

1. Consider appointing two individuals to fill two expiring terms on the Planning Commission and appointing three individuals to fill three expiring terms on the Community Services Commission.

City Clerk Mason presented the staff report.

Mayor Pro Tem Gomez confirmed, for the record, that Councilmember Espinoza had listened to the March 2, 2015, Commission interviews audio tape prior to tonight's meeting.

Council discussion included: clarification of Commission appointment policy of three 3-Year terms or 10 years relating to Commissioner Deborah Musser having served three 3-year terms on the Community Services Commission; confirmation an individual could be appointed to serve for one year of a 3-year term; and clarification regarding the voting process after more than one nomination is made.

City Attorney Jones stated that legally a policy is a statement of intent and there is no legal consequence for violating the policy. He recommended that if an appointment is to be made contrary to the policy that a reason be announced as to why the policy should be overridden at that time.

Mayor Blazey opened the nominations for one individual to fill one 4-year term expiring March 31, 2019, to the Planning Commission. Mayor Pro Tem Gomez nominated Mark Handler, Councilmember Shaw nominated Dawn Holthouser, Councilmember Beamish nominated Manuel Munoz, and Mayor Blazey nominated Mark Lawton. There were no other nominations. MOVED by Mayor Pro Tem Gomez, seconded by Mayor Blazey, and CARRIED UNANIMOUSLY (5-0) TO CLOSE THE NOMINATIONS.

Mayor Blazey opened the nominations for one individual to fill one, 3-year term expiring March 31, 2018, on the Community Services Commission. Councilmember Beamish nominated Deborah Musser to serve one year of a 3-year term. Councilmember Beamish stated he believes Deborah Musser has done well as a Community Services Commissioner and would like to see her continue to serve another year. There were no other nominations.

Council discussion included: confirmation that if the motion fails, Deborah Musser is still in the running for a Community Services Commission appointment; possibly a 3-year term.
