2. Duly noticed public hearing to consider a Negative Declaration of Environmental Impacts 14-01, Zone Change 14-01 from C-3 "General Commercial" to SP-7 "Fairfield Specific Plan", Specific Plan 14-01, Design Review 14-02, and Development Agreement 14-01 for a 335 unit apartment complex at 951-1055 South Beach Boulevard.

Mayor Pro Tem Gomez noted that he used to work for Samsung Church. He reported that City Attorney Jones stated he did not have a conflict due to his previous employment with Samsung Church, but to be cautious he would be abstaining from Item V.2, and left the dais at 6:54 p.m.

Planning Manager Ramsland presented the staff report that included a PowerPoint presentation. He briefly reviewed the project design features and the proposed development agreement.

Council discussion included: concerns regarding traffic patterns and density on Beach Boulevard and Imperial Boulevard; verification the California Department of Transportation (CalTrans) has reviewed the traffic study and will work with the developer regarding the installation of either a double or a single left-hand turn lane into the project; review of residents' concerns; potential increase in parking spaces; potential occupancy rate; clarified that each unit has its own washer and dryer; confirmation pool size sufficient to accommodate 335 residents; verification that the north, south, and main entrances will be cobblestone; water efficiency of each unit; use of artificial turf in community spaces; confirmation the west perimeter wall height was increased from 6-feet to 8-feet to allow privacy; review of the development and other relating fees, and property taxes Fairfield Residential will be bring to the City.

Mayor Blazey opened the public hearing at 7:08 p.m.

Ed McCoy, applicant and representative for Fairfield Residential, thanked Deputy Director of Community Development Jaramillo, Planning Manager Ramsland, and City staff for their time and effort on the project. Mr. McCoy spoke in support of the Fairfield Residential project and presented a PowerPoint that included the Precise Site Plan, proposed landscaping and amenities; building elevations; and examples of recently completed Fairfield Residential communities. He stated the project complies with the City of La Habra General Plan. He noted that he met with neighbors to accommodate and satisfy their concerns. He confirmed that there were 1.18 parking spaces per bedroom, which complies with the Specific Plan and meets industry standards. He clarified that Fairfield Residential will be managing the apartment homes after completion of the project. He thanked City Council and respectfully asked for their approval of the project.

Stephen Garrison, Imperial Beach Self Storage located at 901 South Beach Blvd, spoke in support of the development project.

Bill Mahoney, 2020 Sheffield Drive, spoke in support of the development project. He thanked Ed McCoy and Planning Manager Ramsland for meeting with him regarding parking concerns in his neighborhood from the development of this project.

Don Kolman, 959 Glencliff Street, Treasurer of Woodridge Townhouse Homeowners Association, spoke regarding the parking situation in his neighborhood; and stated that he met with Mr. McCoy who addressed his concerns. He spoke in support of the development project and thanked the Building Department staff for their assistance.

Mayor Blazey closed the public hearing at 7:34 p.m.

Council expressed support of the development project and thanked Mr. McCoy for his involvement with the General Plan Advisory Committee (GPAC) and in getting to know the La Habra community. Council thanked staff for arranging Council tours in South Orange County and for bringing forward the right developer with a quality project.
