1. Duly noticed public hearing to consider an appeal of approval of Design Review 15-05 and Conditional Use Permit 15-02 for the establishment of a restaurant at 1801 West Whittier Boulevard (Continued from September 21, 2015).

Community and Economic Development Deputy Director Jaramillo introduced Senior Planner Schafer who presented the staff report.

Council discussion included: confirmation time frame to mitigate any issues with the condition changes is within 30 days; clarification food served is already being prepared; confirmation any drive through traffic overflow should be contained on site; confirmation of Starbucks Coffee stores opening hours.

Mayor Blazey invited the applicant to speak at 6:40 p.m.

Keith Glassman, on behalf of Starbucks Coffee, thanked Council for the opportunity to reconsider this item. He expressed appreciation to City staff for working out issues so they are acceptable to both parties. He stated Starbucks Coffee will be able to abide by the conditions and operate with sensitivity to their customers.

Mayor Blazey opened the public hearing at 6:42 p.m.

Greg Jones, with Jones Real Estate and the developer on this project, spoke in support of this item. He explained that a 9-foot wall will be built separating the residents from the new construction. He noted the following businesses who will be tenants within this development: Chase Bank, Starbucks, Auto Zone, two fast food restaurants, and an express car wash.

A. CITY COUNCIL:

 Consider a resolution consenting to the inclusion of properties within the City's jurisdiction in CaliforniaFIRST PACE Program to Finance renewable energy, and Energy- and Water-Efficiency Improvements.

Community and Economic Development Director Ho presented the staff report.

Council discussion included: explanation why these programs must be approved by Council; confirmation of interest rates charged and payments made to the program by residents; alternative financing options available to residents; other renewable energy financing companies who have approached the City; confirmation that follow-up has been done on how the HERO program has performed, and the number of La Habra residents the HERO program has financed; renewable energy financing companies operating in other cities; clarification there are no costs to the City from these programs; and clarification the HERO program is strictly residential energy efficiency improvements and California FIRST is both residential and commercial energy efficiency improvements.

Councilmember Shaw inquired if staff has researched Ygrene financing and if the company can be added to this motion. City Manager Sadro confirmed staff has not conducted any research.

City Attorney Jones noted that Ygrene was not on the agenda, and there has been no background or presentation done by staff, so no action can be taken.

Mayor Blazey invited the public to testify at 6:49 p.m. There was no public testimony.

Councilmember Shaw requested to place Ygrene on a City Council meeting agenda at a future date. Councilmember Beamish supported Councilmember Shaw's request.

2. Consider report and presentation regarding covote management in La Habra.

Police Chief Price presented the staff report. He introduced Lieutenant Kent Smirl, who acts as a conservation coach with the California Fish and Wildlife Department. He complimented City staff on their plan and supported education outreach. He stated trapping should be a last resort. He stated that his department is contacted when a human is involved. He explained the term

"carrying capacity," that the number of coyotes is related to the food source, that coyotes will stay within one mile of the food source, and that coyotes are territorial. He explained the coyote yearly cycle, and the potential effects of the rainy weather expected. He explained the community education "Wildlife Watch" program. He stated there is a Southern California Urban Wildlife Management Council that is being formed that cities are becoming involved in to standardize the information being given.

City Council discussion included: coyote trapping process and technique; confirmation that coyotes are motivated by food sources; number of calls received and estimates of coyotes in the area; confirmation coyote activity has increased; importance of community education; reasons for increase of human involved coyote incidents in the City of Irvine; increased pet population increases coyote activity; confirmation the California Department of Fish and Wildlife has not conducted studies regarding the effectiveness of trapping; confirmation the California Department of Fish and Wildlife is only 50 employees down from full capacity; not enough police officers to respond to coyote calls; the purpose of the Police Department working with the California Department of Fish and Wildlife; clarified that the City is not allowed to relocate coyotes that are trapped, so the coyotes would be euthanized; confirmation no specific high coyote activity areas in the City; study by University of California, Davis stating 70 percent of a coyote population can be trapped and it will repopulate within one year; average coyote litter sizes range from 2 to 6 pups and can reproduce at 1 year of age; confirmation education handouts included with dog license invoices, process of choosing locations to place traps; and the cost to trap coyotes.

Mayor Blazey invited the public to testify at 7:19 p.m.

Marie Whittington, 730 Ryan Avenue, spoke regarding her dog falling victim to a coyote and supported trapping coyotes.

Nick Bebek, 1131 North Roddy Drive, spoke in support of educational outreach.

Dianna Raez, 920 Sycamore Avenue, spoke in support of educational outreach and alternative measures. She thanked City officials who have responded regarding coyotes.

Paul Whittington, 1320 Lavita, spoke regarding educational outreach and supported the use of paint guns to deter coyotes.

Kathy Sauble, 2038 Hacienda Road in La Habra Heights, spoke regarding reaching out to La Habra Heights regarding coyote issues. She stated using the siren on her megaphone is effective.

City Manager Sadro suggested that Council direct staff to work with California Fish and Wildlife and a licensed trapper to provide an assessment and report back to Council regarding Coyote activity prior to deciding to trap. Councilmember Beamish agreed with suggestion.

Moved by Councilmember Shaw, seconded by Mayor Pro Tem Gomez and CARRIED UNANIMOUSLY (5-0) TO CONTINUE AND EXPAND EFFORTS TO EDUCATE AND INFORM RESIDENTS, SPECIFICALLY PET OWNERS, REGARDING WILDLIFE IN LA HABRA; SPEAK WITH A LICENSED TRAPPER AND CALIFORNIA FISH AND WILDLIFE REGARDING TRAPPING METHODOLGY; SPEAK WITH SURROUNDING CITIES ABOUT THEIR EFFORTS

REGARDING EXPLORATION OF COYOTE TRAPPING; AND RETURN TO COUNCIL WITH AN ASSESSMENT REPORT ON NOVEMBER 16, 2015.

3. Consider Neighborhood Traffic Management Plans B, D, and I from the Neighborhood Traffic Management Program (NTMP) Priority List Report.

Staff's recommendations were as follows:

- a. Approve Neighborhood B Traffic Management Plan.
- b. Approve Neighborhood D Traffic Management Plan.
- c. Receive and file Neighborhood I Traffic Management Plan.
- d. Direct staff to proceed with the design and construction of traffic calming devices as indicated on the Neighborhood B Traffic Management Plan.
- e. Direct staff to proceed with the design and construction of traffic calming devices as indicated on the Neighborhood D Traffic Management Plan.

Mayor Blazey stated he would abstain on Neighborhood D as he lives in that neighborhood and would leave the dais during that discussion. He requested dividing the item to be considered separately.

Mayor Blazey motioned, seconded by Mayor Pro Tem Gomez, TO DIVIDE THE CONSIDERATION OF NEIGHBORHOOD TRAFFIC MANAGEMENT PLANS B, D, AND I FROM THE NEIGHBORHOOD TRAFFIC MANAGEMENT PROGRAM (NTMP) PRIORITY LIST REPORT INTO THREE SEPARATE SECTIONS.

City Engineer Johansen introduced consultant Steve Brown who explained the Neighborhood Traffic Management process for each of the neighborhoods.

Review of Neighborhood B:

Council discussion included: clarification of consultant's role in process; neighborhood committee size; confirmation of response rate/vote of residents in homes versus apartments; clarification regarding potential emergency vehicle delays, health issues, road rage, decrease in property value, pedestrians, monitoring process and plan modification; and explanation of speed lump, speed hump, and speed bump specifications.

Mayor Blazey invited the public to testify at 8:15 p.m.

The following residents spoke in support of traffic calming measures in Neighborhood B:

Consultant Steve Brown continued the explanation of the Neighborhood Traffic Management Plan for Neighborhood D.

Council discussion included: Review of the input from Police Department, Fire Department, and school district; thanking the committee members and staff for their work on the Neighborhood Traffic Management Plan process; clarification residents have input as to placement of speed

lumps; suggestion to remove two of the speed lumps; confirmation of the minimal impact of speed lumps on cars driven responsibly; clarification that traffic calming is initiated by residents; and the creation of traffic plans and voting process.

Mayor Pro Tem Gomez invited the public to testify at 8:45 p.m.

Chief Price stated the biggest traffic enforcement issue is cut through traffic, and expressed his support of an incremental approach.

4. Consider repealing Ordinance No. 1317 prohibiting fireworks and developing regulations for the sale and enforcement of fireworks City-wide.

Community and Economic Development Director Ho presented the staff report.

Councilmember Beamish asked Chief Price to the podium to speak regarding City of Fullerton's experience with legal fireworks.

Council discussion included: City of Fullerton and City of Chino's negative legal fireworks experiences; confirmation of increase in police service calls and staffing if safe and sane fireworks are allowed in La Habra; increase potential for fires due to increased dry foliage from the drought; confirmation no fireworks injuries occurred this year; potential for cancellation of La Habra fireworks show if safe and sane fireworks are allowed; percentage of the sale of safe and sane fireworks profits are approximately 25 percent; amount of fireworks companies in the United States and in California, confirmation that no lawsuits have been filed in Orange County regarding fireworks; lack of requests for legal fireworks from residents; and potential profits for non-profits if fireworks allowed.
