1. Consider financial report and proposed rate increase for Refuse Enterprise and Water and Sewer Utility Authority Fund for Fiscal Year 2013-2014 and 2014 -2015.

Vice-Chair Beamish confirmed the purpose of the item was to prepare for a public hearing to consider an increase in the rates for water, sewer, and refuse. Public Works Director Saykali briefly explained the proposed increases and the grounds for those increases. Mayor Pro Tem Beamish inquired as to a private program to insure the repairs of waterlines from the curb line to the residence. Public Works Director Saykali explained the program in brief. City Manager Hannah clarified that staff would research this private program further. Vice-Chair Beamish encouraged staff to be prepared with a detailed report regarding the proposed rate increases to be presented at the public hearing.

Mayor Espinoza invited the public to testify at 9:21 p.m. There was no public testimony.

- b. Schedule a public hearing on proposed rate increases for Refuse, Water, and Sewer Operations to be held on June 3, 2013.
- c. Direct staff to prepare and mail notices to property owners of the scheduled public hearing on June 3, 2013, to consider 1) FY 2013-2014 and FY 2014-2015 proposed rate increases for the Water and Sewer Utility Authority Fund; and 2) FY 2013-2014 proposed rate increase for the Refuse Enterprise.
