3. Approve and authorize the Executive Director to issue a purchase order to HD Supply Waterworks, Ltd. in the amount of \$207,732.23 for the purchase of various sizes of water meters for the Annual Water Meter Replacement Program.

III. CONSENT CALENDAR ITEMS REMOVED FOR SEPARATE DISCUSSION:

II.2 Authorize the Executive Director to issue a purchase order in the amount of \$104,027.99 to Sully-Miller Contracting Co. for emergency water main repairs and subsequent street repairs.

Public Works Director Saykali presented the staff report.

Legal Counsel clarified that a conflict of interest does not exist for Director Shaw, who lives within the neighborhood.

Authority discussion included: two consecutive emergency repairs completed on Parsons Street by Sully-Miller Contracting Company; concerns regarding the cause of the two waterline breaks; concerns regarding using Sully-Miller Contracting Company for emergency repairs versus using a local vendor; and clarification that the referenced local vendor is used frequently, but was unable to manage this type of repair.

Public Works Director Saykali explained should it be discovered that the second break was caused by negligence, then the repair cost would not be paid or would be recovered.

Moved by Director Shaw, seconded by Director Beamish, and CARRIED UNANIMOUSLY (5-0) TO APPROVE AND AUTHORIZE THE EXECUTIVE DIRECTOR TO ISSUE A PURCHASE ORDER IN THE AMOUNT OF \$104,027.99 TO SULLY-MILLER CONTRACTING COMPANY FOR EMERGENCY WATER MAIN REPAIRS AND SUBSEQUENT STREET REPAIRS.
