Director Beamish indicated that he did not need a staff report only clarification. Public Works Director Saykali addressed Council's questions.

Council discussion included: clarification that the agreement was negotiated by staff, the agreement is based on a per mile cost, for one year and will service half of the City; potential for negotiating for two years of service to have the entire City serviced at a lower rate; water main flushing for the entire City needs to be completed every three to five years; explanation of ValveTek Utility Services' method of water conservation while flushing water mains; the need for water main flushing; and expression of appreciation for using a method that conserves water.

Chair Espinoza invited the public to testify at 7:32 p.m. There was no testimony.

Moved by Director Beamish, seconded by Director Blazey, and CARRIED (3-0) TO APPROVE TO WAIVE FORMAL BID REQUIREMENTS PER THE LA HABRA MUNICIPAL CODE, SECTION 4.20.070 (B); AUTHORIZE EXECUTIVE DIRECTOR TO SIGN A PROFESSIONAL SERVICES AGREEMENT WITH VALVETEK UTILITY SERVICES, INC. IN THE AMOUNT OF \$300,000 FOR WATER MAIN FLUSHING; AND AUTHORIZE STAFF TO ISSUE A PURCHASE ORDER TO VALVETEK UTILITY SERVICES, INC. IN THE AMOUNT OF \$300,000 FOR WATER MAIN FLUSHING.
